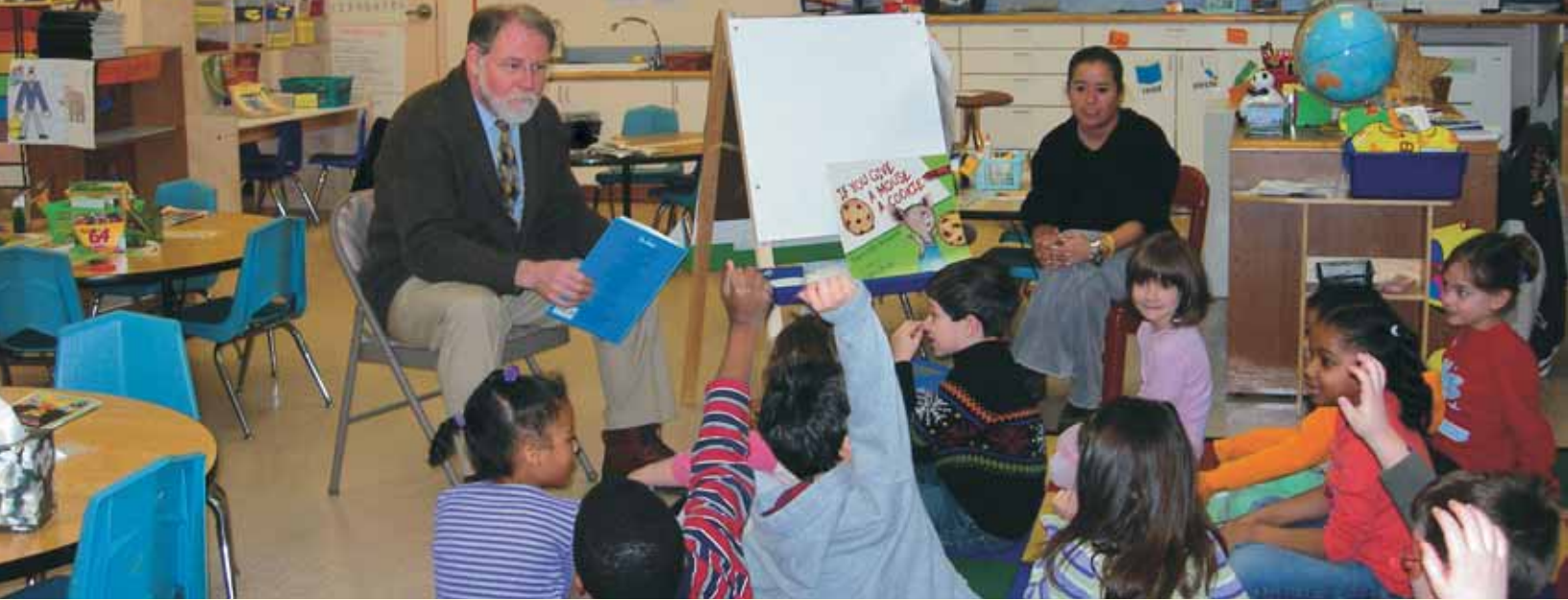
# THE **MISSION** OF CHILDREN'S AID AND FAMILY SERVICES



**Our mission is to preserve, protect and, when needed, provide families. Motivated by compassion for vulnerable children, young adults, frail elderly and their families, we provide high-quality and innovative services that meet their social, educational and emotional needs. Our services include:**

- Group foster homes for children and adolescents who can no longer live with their birth family for a variety of reasons, most commonly abuse and neglect.
- Providing adoptive and foster families for children who continue to heal from the trauma they've endured, and are ready to live with a family.
- Supplying nutritional formula and diapers to low-income working parents of children age newborn through 2 years.
- Offering scholarships to children of working poor parents that enable them to access high-quality educational opportunities, in a nurturing environment, by attending Turrell Child Care & Early Learning Center.
- Clinical support and coaching programs for children and adolescents to help them make healthy and positive life choices.
- Counseling and guidance for the frail elderly, and their caregivers, to help navigate the services available to them.

# MESSAGE FROM

## BOB JONES, PRESIDENT & CEO AND RON VON AUTENRIED, BOARD CHAIR



In life, we all come to a crossroad where we need to assess where we've been and where we're going. Every so often, it is important for all of us to take stock of ourselves and identify how we need to evolve; to look toward the future and back on the past, and see what needs to change. The same can certainly be said for Children's Aid and Family Services, and every other organization with a mission centered on serving the most vulnerable among us.

One of the major strengths of the agency has been its ability to adapt to changing circumstances. For much of our more than 100-year history, we focused solely on placing children in adoptive homes. While this is still one of our specialties, we've continued to evolve to keep pace with a changing world.

The needs of the children we treat today have changed dramatically during the last 25 years. On the whole, the children have more serious problems. They come to us having suffered from

more severe abuse, neglect, and trauma, and having had less basic care. As a consequence, they need more specialized treatment while living in the agency's group or family foster homes to help them start to heal, and eventually move on to a loving and nurturing adoptive or foster family. They need to be thoroughly equipped to build a life of their own once they graduate from high school. To better serve our children, we are continuing to branch out from our roots as an adoption agency, and transform into a children's treatment agency.

Our evolution continued in 2006, particularly in the area of recruiting foster and adoptive parents to love and nurture our children. Many of the agency's foster parents have adopted their children. Although this is wonderful news, it also means we have fewer foster families available. To spotlight the plight of children without families, we implemented an innovative, high-profile public awareness campaign. Large billboards, featuring compelling photos of babies, elementary school-

aged children and older children, along with the agency's contact information, were displayed on major highways in the area, as well as bus shelters and in the Garden State and Paramus Park malls, during the last three months of the year. Additionally, the agency participated in the much-viewed holiday display at Paramus Park mall during November and December. Amazingly, most people have no idea there are so many "orphans of the living" – children whose parents are alive but unable to care for them – desperately in need of families in our community. By capturing people's attention, we've had a tremendous spike in visitors to our website and inquiries from people willing to help. In today's multimedia age, where so many messages compete for the public's attention, we knew we really needed to raise our voices on behalf of the children.

Of course, we are also continuing to provide strong support to the other vulnerable populations we serve, including fragile babies and the frail elderly. And as always, it is only with your help

and commitment that we can successfully fulfill our mission. We thank you for all you do, and would like to share some highlights from 2006 with you (for more highlights, see page 6):

- Adoptions of special needs children in the agency's care increased dramatically, and 27 children were found permanent, loving families. Of those, 20 adoptions were finalized in 2006, and the remaining seven were finalized in the first few weeks of 2007. We normally average 10 such adoptions per year, so this is a remarkable feat.
- The Baby Basics program continued to provide nutritional formula and diapers to low-income, hardworking families in Bergen County with children ages infant through 2 years. In 2006 alone, approximately 142,200 diapers and more than 15,000 ounces of formula were distributed, and donations increased by an impressive 47 percent from the prior year.

- Turrell Child Care & Early Learning Center provided scholarships to 84 working poor families, allowing their children to attend the center and receive high-quality educational opportunities in a nurturing environment. Two new classrooms also opened at the Center, along with a new infant/toddler playroom.
- The agency's Elder Care program expanded in 2006, with social work support provided at the senior centers in Garfield and Hackensack, as well as Midland Park. We assisted more than 750 frail senior citizens in our community to enroll in Medicare Part D, helping them to access vitally needed prescription medications and stretch their low budgets. We also began to serve the often overlooked population of deaf seniors, by providing sign language interpretation.

We achieved many goals last year in a challenging environment, and we expect next year to continue to be filled with positive changes and opportunities for growth. Because of you and your generous support, we helped more than 12,000 vulnerable children and families in 2006. This is quite an accomplishment, and exemplifies the impact you have on our shared community by working together with so many other volunteers, donors, and staff.

On behalf of the Board and our staff, we thank you for your tremendous commitment to Children's Aid and Family Services.

# MEMORABLE

## MOMENTS IN 2006



- Since the Boarder Babies program's inception in 1996, more than 150 babies and foster families have been served. If it weren't for this program, these vulnerable babies would languish in local hospitals without the love and nurturing of a family.
- Congratulations to Anne Oros, a foster mother in the Boarder Babies program, and Kathleen Russo, administrator of clinical services for the agency, who were recognized by the United States Congress as "Angels in Adoption."
- The agency established a Youth Advisory Board after receiving a grant from the State. It is comprised of children currently residing in group and treatment foster homes, and serves as a forum for them to voice their opinions about the child welfare system, and speak on behalf of their peers. The Youth Advisory Board is also committed to giving back to the community. In fact, last year they raised more than \$2,400 (including a matching gift) to support the children of the Espwa Orphanage in Haiti.
- The Dave Thomas Foundation for Adoption renewed the Wendy's Wonderful Kids grant the agency receives to fund an adoption recruiter. This is a tremendous boost to the agency's efforts to find permanent, loving homes for the older children available for adoption. Additionally, the Dave Thomas Foundation for Adoption, The Children's Action Network, and CBS Television presented the eighth annual *A Home for the Holidays*, a nationally televised program designed to raise awareness about foster care/adoption, and to enhance recruitment efforts nationwide. For the fourth year in a row, agency-run NJ ARCH (New Jersey Adoption Resource Clearing House) was the statewide contact. After the special aired, NJ ARCH received 123 calls from people interested in more information about adoption.

# MEMORABLE

## MOMENTS IN 2006



- Several staff members of Turrell Child Care & Early Learning Center were trained in the HALO (Healthy Alternatives for Little Ones) program, developed by Heartland Family Services of Nebraska, and funded by the William Randolph Hearst Foundations. They are now the first HALO-certified teachers in the northeast section of the United States, and have instructed teachers from several other child care centers in Bergen County.
- The renovation of the agency's flagship building at 200 Robin Road in Paramus was completed on-time and within budget. Administrative costs were reduced as this enabled us to vacate two rental offices.
- Philanthropy to the agency increased 20 percent last year. This additional revenue was critical to the agency's operations, as the cost of delivering high-quality programs has gone up at an astronomical rate, while support on the state and federal levels has declined.
- Thank you to the hardworking, talented volunteers at The Depot, an all-volunteer gift and craft shop, who exceeded their pledge goal to the agency by \$40,000!
- Community support continued to play a vital role in the agency's fiscal health and growth in services, with many small businesses, corporations, organizations, foundations, and individuals getting involved in 2006, including: Arthur Groom & Co., Irwin Franchise Capital, J. Mark McVey and the Ridgewood United Methodist Church, the faculty and students of Bergen Technical High School, as well as the many village businesses that purchased properties in *Ridgewoodopoly*.

## LIFETIME GIFTS

### THE ANNE GOHEEN CRANE ENDOWMENT FUND

The agency's principal endowment fund provides unrestricted funds to areas of greatest need. Interest from the fund provides the agency's only source of reliable income. It is used to support mission commitments to: keep services accessible to all, regardless of ability to pay; provide the ability to anticipate changing needs and respond to the unexpected; and to be less vulnerable to economic fluctuations.

**THE ETHEL G. AND ARTHUR B. TOAN, JR. FUND**  
This fund provides unrestricted support to any area of need within the agency.

**THE ANNE AND JOHN OROS FUND**  
This fund provides dedicated college scholarship support for children who were fostered as infants by the Oros family, and, in the future, to support other teens who have aged out of foster care and are attending college.

**THE MARGARET PASMANTIER COMMUNITY  
LIFE EDUCATION FUND**  
Established in memory of Margaret Pasmantier, a long-time agency volunteer, this funds a variety of community education programs.

**THE JULIE LYNNE ZIPPER MEMORIAL FUND**  
This fund was established in memory of Julie Lynne Zipper, a tragic victim of the World Trade Center attacks of 2001. As a lasting tribute to Julie and in recognition of her love for the

Turrell Child Care & Early Learning Center in Paramus — attended by her son Jason — the fund provides scholarships for staff members who wish to further their education in early childhood learning.

### THE THOMAS R. BURGIN EDUCATIONAL SUPPORT FUND

This fund provides financial assistance to teens aging out of foster care and attending college or vocational training. It is also available to fund tutoring and other special educational needs for children in the agency's care. Teens graduating from foster care within the State are eligible for free tuition, room, board, and selected educational expenses, provided they study in New Jersey. However, they have no means of financial assistance to fund clothing, toiletries or other day-to-day living expenses. The Thomas R. Burgin Fund provides this support.

**THE LEDA M. JADROSICH FUND**  
Established in memory of Leda M. Jadrosich, this fund supports all aspects of the agency's adoption services for vulnerable infants, children and teens — from helping them heal to recruiting loving adoptive families for them.

**THE RUTH L. AND WILLIAM F.  
WARMINGTON FUND**  
An endowed fund to support the core infrastructure needs of the agency, such as communications, development, and the professional development of leadership staff.

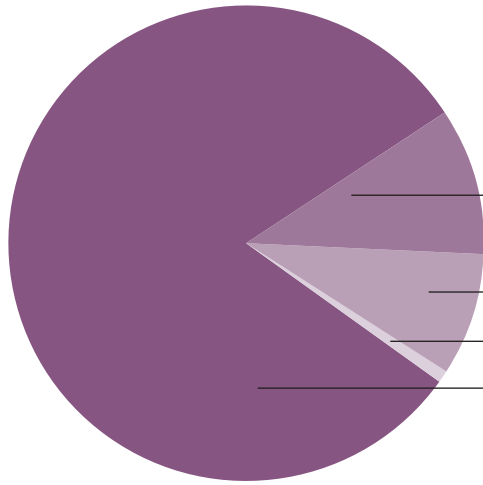

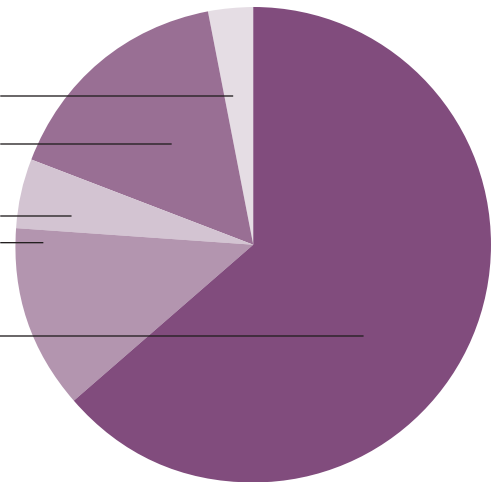
